Notice is hereby given that on Tuesday the 15th day of May, 2018 at the polling places in Butler County, Nebraska, an election will be held. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for nominating candidates to various offices. Some races will not appear on the Primary Election as the number of candidates filing for office did not exceed twice the number of vacancies; these candidates are declared nominated and will advance to the November 6th General Election, when candidates for township officers, village board members, public power district boards (grossing under \$40 million), and educational service unit board members also may be elected.
