

BUTLER COUNTY BOARD OF SUPERVISORS

March 19, 2018

A meeting of the Board of Supervisors of Butler County, Nebraska was held on the 19th day of March, 2018 at the Butler County Courthouse in David City, Nebraska at 9:00 a.m.

Present were the following: David W. Mach, Tony Krafka, Kevin Slama, Max Birkel, Scott Steager, and Greg Janak. Absent: David Potter.

Notice of the meeting was given in advance thereof, by Publication, a designated method for giving notice, as shown by the Proof of Publication attached to the minutes. Notice of this meeting was given to all members of the Board and a copy of their acknowledgement of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to all members of the board of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

The Chairman called the meeting to order, and announced that a complete copy of the Open Meetings Act is posted in the meeting room.

The Chairman declared the minutes of the previous meeting shall stand approved as presented.

Permit to Construct Utilities on County Right-of-Way

A permit to construct utilities on County right-of-way was submitted by Butler Public Power District to install a power line beginning from the intersection of 41 Road and QR Road on the east side of QR Road, extending south approximately 1,350 feet.

A permit to construct utilities on County right-of-way was submitted by Butler Public Power District to install a power line beginning approximately 900 feet east from the intersection of Q Road and 41 Road on the south side of 41 Road, extending east for approximately 2,400 feet.

Jim Rerucha, Highway Superintendent reported that the County has received STP Funds in the amount of \$129,284.19, and Bridge Funds in the amount of \$30,082.32. These funds are the allocated distribution from the Federal Funds Purchase Program.

Bellwood Paving Update

Discussion was held pertaining to paving H Road on the east side of Bellwood. The county and village share the responsibility of maintaining the road. The Highway Superintendent will obtain additional information from the contractor as to the costs associated with the project.

Clerk of the District Court Fee Report


The Clerk of the District Court fee report for the month of February, 2018 was accepted and placed on file.
