Village Ticket

Village of Rising City

"Shall the governing body of the Village of Rising City, Nebraska, impose a sales and use tax of one percent (1.00%) upon the same transactions within the Village of Rising City on which the State of Nebraska is authorized to impose a tax, for a twenty (20) year period ending October 1, 2040, with the proceeds collected to be used for capital improvement including, but not necessarily limited to, city streets, city water and city sewage systems?"

If a majority of the votes cast upon such question shall be in favor of such tax, then the governing body of the Village of Rising City shall be empowered as provided by Section 77-27,142 and shall forthwith proceed to impose a tax pursuant to the Local Option Revenue Act. If a majority of those voting on the question shall be opposed to such tax, then the governing body of the Village of Rising City shall not impose such tax.
